

The term “sovereignty” has had different meanings through history. Also today, it is used for many purposes in national and international politics. In Europe, international lawyers tend to be critical of that concept. According to the world-renowned international law professor Martti Koskenniemi, their scepticism might be rather shortsighted sometimes. As he states in an essay published in 2011 in the Asian Journal of International Law, sovereignty “articulates the hope of experiencing the thrill of having one’s life in one’s own hands. This is what sovereignty meant for those who struggled against theocratic rule in early modern Europe or invoked it to fight for decolonization in the twentieth century. Today, it stands as an obscure representative of an ideal against disillusionment with global power and expert rule. In the context of war, economic collapse, and environmental destruction, in spite of all the managerial technologies, sovereignty points to the possibility, however limited or idealistic, that whatever comes to pass, one is not just a pawn in other people’s game but, for better or for worse, the master of one’s life.”

In Switzerland, the concept of sovereignty is at the heart of the most emotionally debated political question today: Who has the last word when decisions taken through direct democracy contradict Switzerland’s international obligations? While currently more and more decisions adopted through direct democracy contradict important binding international treaties, like the European Convention on Human Rights or the Agreement on free movement of persons with the EU, this determining question has not been answered yet. There will be time to discuss the concept of sovereignty with Martti Koskenniemi. His thoughts should lead to a nuanced debate – not just a simple discourse on the “good” or “bad” in international law.
